Whereas, The Government Medical College, Handwara, advertised vacant positions of Senior Residents and Tutors in various departments through Advertisement Notification No. 06 SR (GMCH) of 2025, Dt: 28-04-2025 purely on an Academic Arrangement basis as per S.O. 364 of 2020, Dated:27-11-2020.

Whereas, in continuation of Office Order No. 31- SR(GMCH) of 2025, dated 27-05-2025, regarding the selection of Senior Residents in Department of General Surgery of Government Medical College Handwara a provisional selection and waiting list was annexed as **Annexure II** & **III** in the given the office order.

Whereas, subsequently 01 Candidate has submitted resignation from the post of Senior Resident in the department of General Surgery on 16/06/2025.

Henceforth based on vacancy available and as per rules envisaged in Government Order No. 382-JK(HME) of 2024, dated 20-06-2024 and upon operationalization of waiting list, 01 candidate mentioned in waiting list (as annexed in *Annexure III* of Office Order No. 31- SR(GMCH) of 2025, dated 27-05-2025) namely **Dr. Hilal Ahmad** (MS-*General Surgery*) (non-PSC) is selected for the post of Senior Resident in department of General Surgery of Govt. Medical College, Handwara on Academic Arrangement basis as per S.O 364 dated 27-11-2020.

However, engagement of the selected doctor shall be subject to the following conditions:

- That the doctors shall submit their joining report in the office of Principal Govt Medical College Handwara within 07 days from the date of issuance of this selection order.
- 2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
 - I. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - He/she will not indulge in private practice during the tenure. In case he is found doing private practice his appointment shall be terminated without any notice.
