Subject: Operationalization of 2nd Waiting List for the tenure position of Junior Residents in various departments of Government Medical College, Handwara, on Academic Arrangement Basis under S.O. 364 of 2020.

Whereas, Government Medical College, Handwara issued Office Order No.67- JR (GMCH) of 2025 dated 24-12-2025, regarding provisional selection of candidates for engagement as Junior Residents on Academic Arrangement Basis under S.O. 364 dated 27-11-2020; and

Whereas, the written examination (MCQ OMR-based) was conducted on 18-11-2025, and selection was made strictly on the basis of merit and availability of vacancies; and

Whereas, Government Medical College, Handwara issued Office Order No.02- JR (GMCH) of 2025 dated 06-01-2026, regarding operationalisation of 1st waiting list for provisional selection of candidates for engagement as Junior Residents on Academic Arrangement Basis under S.O. 364 dated 27-11-2020; and

Whereas, in accordance and continuation with the said order, a waiting list is required to be maintained for a period of three (03) months to meet contingencies arising out of non-joining or resignation of provisionally selected candidates within the prescribed joining period;

Now, therefore, the candidates listed in **Annexure-I (2nd Waiting List)** to this order are hereby provisionally selected for engagement as Junior Residents in Government Medical College, Handwara, for the departments mentioned against each name, strictly in order of merit, owing to the failure of joining by certain provisionally selected candidates, resignations thereafter, and completion of tenure of some Junior Residents, and shall be governed by the conditions detailed hereunder.

*The departments allotted to the provisionally selected candidates shall be allotted strictly in accordance with the sanctioned strength of each department of Government Medical College, Handwara. However, the said departmental allotment shall remain subject to change, at any stage, as per institutional requirements and administrative exigencies, after completion of joining and document verification formalities.**

However, as per the terms and conditions of the advertisement and rules governing engagement, the selected candidates shall be appointed on **Academic Arrangement Basis** initially for a period of six (06) months, extendable up to a

maximum of **one (01) year**, subject to satisfactory performance and good conduct report from the concerned Head of the Department/Section.

However, engagement of the selected doctors shall be subject to the following conditions:

- 1. Joining and Document Verification:** Candidates must submit a joining report along with all original documents (as specified in **Annexure II**) for verification at the Principal's Office, Government Medical College, Handwara, within Seven (07) days of the date of this order. Failure to comply will result in the cancellation of the candidate's appointment.
- 2. Affidavit Submission:** Each candidate shall submit an affidavit, attested by a First-Class Magistrate, affirming:
 - i. Non-involvement in any criminal activity or pending FIR.
 - ii. Commitment to refrain from private practice during the tenure, with immediate termination upon any violation.
 - iii. Commitment to complete the sanctioned tenure without resignation.
 - iv. Agreement not to participate in any form of strike, as services are governed by the Essential Services Maintenance Act (ESMA).
 - v. Adherence to professional conduct standards, with termination of service for any misconduct.
- 3. Security Deposit:** The first month's salary shall be held in deposit by the Accounts Department as security, to be released upon successful completion of the initial tenure of 06 months.
- 4. CID Verification:** Salary disbursement is contingent upon satisfactory CID verification.
- 5. No experience certificate** will be issued if he/she leaves without completing his/her sanctioned tenure.
