Whereas, The Government Medical College, Handwara, advertised vacant positions for Senior Residents and Tutors in various departments through **Advertisement Notification No. 11- (SR) of 2025, Dt: 17-07-2025** purely on an Academic Arrangement basis as per S.O. 364 of 2020, Dated:27-11-2020.

Whereas, in continuation to office order no. 47-(SR) GMCH of 2025, Dated:13-08-2025, Government Medical College, Handwara conducted Multiple Choice Question (MCQ) OMR Based Test on 21-08-2025 for the departments of **Obstetrics & Gynaecology and Orthopedics** as per Criteria/Policy guidelines for eligibility and selection to tenured positions, as specified in Govt Order No. 383-JK(HME) of 2024, Dt:20/06/2024.

Whereas, the result of marks obtained in MCQ-based (OMR) written test by all the candidates is attached as **Annexure I** to this notification.

Therefore, based on the marks obtained in the MCQ-based (OMR) written test and vacancies available in the department of Orthopedics and Obstetrics & Gynaecology, candidates listed in **Annexure II** of this notification are hereby provisionally selected for the tenured positions in the given department. The waiting list of candidates is attached as **Annexure III**, which shall be valid for 03 months, in case of failure of candidate to join, or in case candidate leaves the tenured position midway, the next candidate in the merit list will be invited to join.

However, as per the advertisement and rules of engagement, the candidates are provisionally selected on academic arrangement basis initially for a period of **01 year** which can be extended to a maximum of 03 years based on performance and good conduct report by the concerned head of the department/section.

However, engagement of the selected doctors shall be subject to the following conditions:

1. That the doctors shall submit their joining report in the office of Principal Govt Medical College Handwara within **10 days** from the date of issuance of this selection order.

2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
 - I. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - II. He/she will not indulge in private practice during the tenure. In case he is found doing private practice his appointment shall be terminated without any notice.
 - III. He/she shall not leave the department before the completion of his/her sanctioned tenure.
 - IV. He/she will not participate in any kind of strike during the period of his/her tenure as the services are covered under ESMA.
 - V. He/she shall remain disciplined during the tenure period and any kind of misconduct shall make him/her liable for termination without any prior notice.
3. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment of 01 year.
4. Salary will be disbursed only after the proper **CID Verification** of the candidates.
5. No experience certificate will be issued if he/she leaves fails to serve his/her tenured position for at least 06 months.
